As a NCAA member institution, SUNY Polytechnic Institute is required to annually gather information regarding the prior misconduct of any current/returning, prospective, or transfer student, including a graduate student, who seeks to participate in intercollegiate athletics. Specifically, any current, prospective, or transfer student-athlete, including a graduate student, must annually disclose whether they have been found responsible through a campus proceeding and/or had a criminal conviction for sexual, interpersonal or other acts of violence. This misconduct is defined as:

- *Interpersonal Violence*: Violence that is predominantly caused due to the relationship between the victim and the perpetrator, including dating violence and domestic violence.
- *Sexual Violence*: A term used to include both forcible and nonforcible sex offenses.
- *Other Acts of Violence*: Crimes and/or conduct including murder, manslaughter, aggravated assault or any assault that employs the use of a deadly weapon or causes serious bodily injury.
